Organization and by any private practitioner is an Offence under Section 13(3) of RCI Act No. 34 of 1992" (copy enclosed). The same is as under:

"Any person who acts in contravention of any provision of sub-section (2) shall be punished with imprisonment for a term which may extend to one year, or with fine which may extend to one thousand rupees, or with both".

In this connection, Hon'ble Minister (SW) has directed to convey that essential service during physical, mental & vocational rehabilitation in the lives of person with disabilities are technical in nature hence needs to be checked through a legal framework.

Govt. sector is particularly violating the established rules meant to protect the rights of persons with disabilities in respect of services not being provided by the RCI registered professionals.

It is the high time to act and take corrective measures by the department of Administrative Reforms of Delhi, therefore, it is request that Administrative Reforms Department must issue an order/ instructions that in every department where posts are existing or will be created for the services in Homes, Institutions, Rehabilitation centers and any other setup for persons with disabilities section -13 of RCI Act will be mandatory to follow for which departments are requested to complete all administrative approvals from their competent authorities.

It is further emphasize that all sensitive posts which are responsible for supervision, monitoring and policy framing of services which are not only technical in nature but also required skillful/ expertise of professionals in disabilities like Mental Retardation Locomotor Disabilities, Visual Impairment, Speech and Hearing Impairment, Hemophilia Muscular Dystrophy etc. for which only Rehabilitation Council of India and Occupational Therapy (OT) & Physical Therapy (PT) Council of Delhi are authentic Govt. approved bodies which are strictly monitoring the Research and Development program for persons with disabilities.

Such reforms will surely improve the quality of services for 21 categories of disabilities covered under the Rights of Persons with Disabilities Act 2016.

We do believe as your good self could lead our movement of rights based society and towards more growth and improvement over the organizations commitment towards quality services at society.
