Madam/Sir,

I am directed to inform you that as per existing policy, revision of Electoral Rolls with reference to 01st January of the coming year as the qualifying date is done in later part of each year. Accordingly, Election Commission of India has directed to conduct Special Summary Revision of electoral rolls w.r.t. 01.01.2020 as qualifying date, in NCT of Delhi as per schedule given below:

4.	Special campaign dates	02.11.2019, 03.11.2019, 9.11.2019 & 10.11.2019
5.	Disposal of Claims and Objections	By 15.12.2019
6.	Final publication of Electoral Rolls	01.01.2020 to 15.01.2020 (Probable dates)

During the period of Electors Verification Programme (EVP), every elector has to authenticate their details in the electoral rolls by giving copy of one of the following documents:-

- (i) Indian Passport
- (ii) Driving License
- (iii) Aadhaar
- (iv) Ration Card
- (v) Identity Card for Government/Semi-Government officials
- (vi) Bank Passbooks
- (vii) Farmers Identity Card


The citizens can verify and correct their details through "Voter Helpline" Mobile App, National Voters' Service Portal www.nvsp.in and also at the Voter Centres of concerned Assembly Constituency. BLOs of the concerned area will also carry out House to House verification in all parts of NCT of Delhi.

Further, during the period of filing claims and objections i.e. 15.10.2019 to 30.11.2019, any eligible person including those who will be completing 18 years of age on 01.01.2020 can apply for inclusion of their name in the electoral roll in NCT of Delhi. The application for inclusion in electoral roll may be made in Form-6, deletion of an existing entry from the electoral roll in Form-7, correction in existing entry in Form-8 and change of address within same Assembly Constituency in Form-8A. All these Forms can be downloaded from the website of this department www.ceodelhi.gov.in. Further, the application in concerned Form may also be made online at www.nvsp.in.

In this regard, I am directed to request you to kindly bring the above information to the notice of all employees of your department and motivate them to participate in the Electors Verification Programme (EVP) by verifying their details in the electoral rolls through "Voter Helpline" Mobile App, National Voters' Service Portal www.nvsp.in and also at the Voter Centres of concerned Assembly Constituency. It is necessary to participate in EVP to make the electoral roll of NCT of Delhi error free.


